Elizabeth Rumsey Joins Miller Starr Regalia As Litigation Associate In Walnut Creek; Star Lightner Joins As Senior Attorney Editor Of Firm's *Miller & Starr, California Real Estate*

She will work with Karl Geier, transactional shareholder and editor-in-chief of *Miller & Starr, California Real Estate 3d*, a 12-volume authoritative treatise that is the most widely used and cited California real estate law reference for lawyers, judges and real estate professionals.
