REPRESENTATIVE MATTERS

Won a motion for summary judgment on behalf of a homeowner dismissing the plaintiff's complaint for premises liability because the alleged assault did not occur on our client's property and because our client was not liable for third-party criminal conduct.

Represented the distributor of research laboratory products in a complex litigation action involving claims for breach of a commercial real estate contract and environmental contamination. Assisted the client in ensuring compliance with CLRA.

Represented the manufacturer of a nationally distributed product to ensure compliance with the Toxic Substances Control Act under the EPA. We also assisted the client in complying with CLRA and other EPA rules.

Negotiated a highly favorable settlement on behalf of a commercial landlord to resolve a dispute involving claims for breach of contract brought by its commercial tenant after the client exercised its option not to renew the lease.

Won a motion to strike the plaintiff's claims for punitive damages for alleged negligence and premises liability on the grounds that the plaintiff failed to produce evidence showing punitive damages or any cause of action that would support said damages were warranted.

Successfully negotiated additional reasonable accommodations for a minor, including a part-time aide on behalf of a parent of a child with disabilities.

Won a motion for attorneys' fees and costs in DC federal court based on "lodestar" calculation (special education law), determined by the court to be appropriate in light of the successful outcome at the administrative hearing on behalf of the parent and guardian ad litem of a child who had been denied a free and appropriate public education.

Represented the parent of a child with disabilities to develop a behavioral intervention plan and secure an appropriate least restrictive environment in compliance with the Individuals with Disabilities Education Act.
